Energy affordability and security a top priority

With mill and industry slowdowns due to escalating electricity prices, a core current focus of WPMA is advocating for Government led solutions to lower prices and enable certainty to future direction. Both industry and our members have been involved in numerous meetings and discussions. In a meeting held with Minister for Energy, Simeon Brown, this week he emphasised that Government has a significant role to play by removing barriers to competition, and that opposition parties support is needed to secure longer term direction. The government is not 'picking winners' and all energy sources are being considered. The overall goal being affordable prices and energy security. We are supportive of the overall goal, but still share concerns that policy changes will not be enough to provide the required immediate financial relief, both for small mills that are unable to hedge against the market, and the larger operators who are energy intensive. Our hope is that outlined actions will lead to future certainty.

European Union Deforestation Regulations – WPMA working towards an NZ solution

With the aim of ensuring European Union consumption does not contribute to global deforestation and degradation of forest ecosystems, the EU has introduced regulations that will be enforced on six commodities, including wood products, from the 29 December 2024. The key information required in the due diligence statements will be provision of geo-coordinates of all plots of land where the wood was harvested, and evidence that the wood is deforestation free, i.e. before and after proof. WPMA is working on the assumption that EUDR will happen and has formed a working group that includes WPMA members, Forest Owners' representatives, and MPI. Several meetings have been held and good progress is being made as to developing solutions. Our overall goal is to ensure market access to the EU continues for our wood product exports.

Health and safety meeting with Minister van Velden for WPMA members

To ensure our voice is heard, WPMA and our members will be meeting with Minister for Workplace Relations and Safety, Brooke van Velden, and her officials on the 3 September in Napier. The purpose of the meeting will be to discuss the proposed Health and Safety reform, with a particular emphasis on how Worker Exposure Standards are set. It is important industry has more purposeful engagement with government when it comes to providing feedback into regulatory requirements for wood processing and manufacturing businesses. Built environment must be part of the Emissions reduction planning

Actions to boost wood processing as outlined within the ERP2 proposals must also include the 'Building for Climate Change' programme and the 'Lowest carbon procurement policy' for new government buildings. These initiatives include targets of reducing carbon emissions in all new buildings using mass timber in the place of steel and concrete. The Government needs to act on these policy initiatives, along with addressing regulatory barriers to enable building with wood, enacting policy on harvested wood product credits, and improving the consenting framework for wood processing. We agree that climate change is a global problem. New Zealand contributes to this problem and has a responsibility to address it. Wood processing and manufacturing has a crucial role to play in achieving the reductions sought under the Paris Agreement. See more in our submission: as highlighted below.

Wooden wind turbines a hot proposition

Wooden wind turbine construction is taking off in Nordic countries using laminated wood (LVL) rather than steel and concrete. The LVL used is 50 percent stronger per kilogram, than the steel used in wind turbine towers today. The result is a lighter tower which becomes more beneficial the taller you build. The wooden towers have greater than 100 percent less emissions, and 30 percent total carbon reduction for the industry. These towers are constructed with about 25 percent of the emissions profile of a standard turbine. Because they go higher – up to 200 metres – they can generate up to 8 times as much energy. Concrete and steel turbines cannot go so high because of construction and transport limitations. In essence, a wood laminate is curved, and sections are constructed and fitted together according to the height desired for the turbine. *Pinus radiata*, New Zealand's core plantation crop, has been confirmed as a viable timber option for constructing the wooden wind towers. Although the wooden turbines are a relatively new concept, New Zealand opportunities to supply timber for wooden wind turbine construction would assist in growing the sector, provide an additional option for energy production, and reduce our emissions profile.



Turning Green to Gold – impact of green certification

Research by JLL highlights that Green Star certification demonstrates a premium of 3.7 to 7.5 percent for new buildings. Geen certifications globally are driving real estate returns worldwide, revolutionising sustainability and environmental performance in buildings and demonstrating value to occupiers, owners and investors as reported by JLL. Not only is this increased market value a core benefit to investors, but a flow on value is the reduction of carbon emissions within the built environment.
