The recent drop in the Official Cash Rate to 3.75 percent is set to further boost this momentum, making financing more accessible and encouraging investment in new projects. On top of this the proposed new projects within the Fast Track approvals process will further expedite infrastructure and development projects across New Zealand. All these factors will hopefully lead to greater demand for our local wood products, which in turn will boost our sustainable forestry and wood processing industry. A strong domestic timber market tends to lead to an increase in exports of value-added wood products, which is both positive for our industry and our wider economy. Green shoots for Manufacturing and NZ Business

Recent BusinessNZ surveys suggest possible green shoots of economic growth in New Zealand.

The <u>BNZ-BusinessNZ Performance of Manufacturing Index</u> and <u>BNZ-BusinessNZ Performance of Services Index</u>, which give a monthly reading on the state of the manufacturing and services sectors, have both indicated expansion in their most recent results. Previously the PMI and PSI surveys recorded sectoral declines over the last 10 months (services) and 22 months (manufacturing). The latest month's results, while not conclusive, give some cause for optimism.

United States talks trade and tariffs

At certain times in our history a decade happens in a month, and with Donald J Trump being inaugurated as the 47th President of the United States on the 20 January it sure feels like the world has been turned upside down in the last 4-5 weeks. From a New Zealand wood products exporter perspective, we are watching closely on the tariff front as to what may eventuate. To date, there has been a lot of noise, but fortunately we have been spared any tariffs on our \$340 million plus of

exported wood products to the USA. The United States is an important export market for many of our members, with the potential for growth given our sustainable and high-quality timber. The Ministry for Foreign Affairs trade officials see the USA situation as one of their main priorities, with intelligence requested from industry and exporters. We will continue to support our trade officials and members as they endeavour to engage and transpose any proposed tariffs on NZ wood exports to the USA.

Future of training and education for wood processing and manufacturing at risk

Plans to close the Toi Ohomai, Waipa Timber Industry Training Campus in early 2026 could leave a large hole in the wood processing sector for Timber Machinists and Saw Doctors apprentice training. This announcement, along with the proposed government changes to vocational and education reform, will lead to a transformed landscape for future wood processing and manufacturing training. With predicted skilled staffing shortages for key positions within wood processing, there is a risk that a lack of trained staff for mills will result in slowing industry growth and economic returns for New Zealand. To ensure our industries future is secured for trained mill staff, a collective of wider industry, Toi Ohomai, training providers, and government will be working together over the coming months to discuss options with the goal of implementing a workable and affordable solution for future training. Improvements to Resource Consenting process supported by WPMA

The Wood Processors and Manufacturing Association supports the latest RMA amendment Bill which aims to reduce the regulatory burden on resource-seekers and resource-holders. Our submission on the Bill recommends extending resource consents beyond 35 years for long-life assets, such as wood processing mills (for greater investment certainty), mandating that decisions on wood processing facilities and specified energy activities must be issued within one year of consent application being lodged, and making it easier to gain consents for building and construction projects.

Vietnam meeting results in WIN for New Zealand wood processors

As reported in our December 2024 Newsletter, representatives of the wood processing and forestry sector met with a delegation of Vietnamese industry leaders as to business and investment opportunities. This meeting has already produced positive results, with the Vinafor (Vietnamese Forestry Corporation JSC) delegate requesting to connect with NZ suppliers of high-quality sawn radiata pine timber. Vinafor currently import pine COL, mill run and Industrial grade for furniture and packaging/pallet manufacturing. They are looking at a monthly volume of 20-40 containers of NZ pine timber, with the potential for further business opportunities. WPMA is working in with Vinafor as to connecting interested members with this export opportunity. Noting that as an industry Association our only interest is to provide our WPMA members with potential business opportunities and benefits. We do not involve ourselves in any commercial matters or negotiations.

New Zealand Government dallies in recognising mass timber as our future sustainable building material

While global trading partners such as the United States and Canada are progressively recognising and incorporating mass timber products in construction projects, the New Zealand government is doing the opposite by cancelling the Building for Climate Change programme, for example, and other initiatives aimed at supporting low emissions building and construction materials. According to an international Research and Market report, Government amendments are being enacted in building codes, particularly in North America and Europe, to accommodate and encourage the use of mass timber products in building and construction projects. As these standards become more prevalent, they install confidence in architects, engineers, and builders to adopt mass timber in a wider range of projects.

Globally, the mass timber market is experiencing steady growth driven by the escalating shift towards green building practices, supported by government regulations and eco-friendly building standards, increasing environmental awareness among consumers, and the growing demand for sustainable construction materials. With key allies such as the United States, Japan, Australia, and Great Britain committed to recognising the benefits of wood through signing a pledge for increased timber in construction at COP 28, New Zealand now needs to reflect and join the mass timber movement. India – New Zealand trade relations theme of business forum

At the recent business forum 'A new era of New Zealand-India business relations' the Minister for Trade & Investment, Hon Todd McClay noted that "India is a key relationship, and we are committed to delivering growth across all levels." As the wood products and forestry industry looks at rebuilding our exports to India, it is important to build relationships with India and to have the Minister's support. Common themes at the forum included the need for policy alignment, sustainable practices, and investment in emerging sectors, along with the adage 'the time to act is now'. New Zealand needs to take proactive steps to deepen engagement with India, establish stronger business relationships, and ensure that it is not left behind by other markets such as Australia. As panellist Bharat Chawla commented "India and New Zealand relations are in their best phase of growth, and a strong push from businesses, the diaspora, and both governments will help to reach the best outcome for both countries."

Immigration – Accredited Employer Work Visa scheme reforms webinar

In December 2024, the Government announced reforms to the Accredited Employer Work Visa (AEWV) scheme, which will be implemented over the course of 2025. These changes include removing the median wage threshold, reducing experience requirements to 2 years and introducing new seasonal visa pathways to support employers to fill skill gaps. The changes will be implemented in 4 different stages over the course of 2025. ImmigrationNZ are holding a webinar to explain more details of the changes on the 5 March.
